The Pennsylvania Association of Milk Dealers (PAMD) and Pennsylvania Association of Dairy Cooperatives (PADC) jointly move for an additional two-week extension of time to submit our joint compromise proposal for review and approval by the Milk Marketing Board. We are still working with interested parties to determine if they will object to the proposed compromise.
