1. Over-Price Premium OGO A-1009 Amended

Section II will now read (with added language bolded): The calculation of the over-price premium shall exclude **from Pennsylvania receipts** pounds of milk received by cooperative-owned plants to the extent milk is supplied to a cooperative-owned pant from **Pennsylvania** members of the cooperative that owns the plant, **but will be included in total receipts**.
