#### 6. REPORT OF CHIEF COUNSEL:

**DISCUSSION:** Attorney Eberly stated that on 12/18 the Board met to discuss the Line Item Regulation which will soon be completed and submitted as a final form. The Board also discussed the Board Secretary position, in preparation for the upcoming interviews. No deliberations nor official actions were, nor will be taken.

#### 7. LEGAL CASE DISPOSITIONS

1. Sun Re Cheese Corporation Dealer failed to account and make payment for milk delivered to it by a producer

**PRESENTED by**: Attorney Eberley

**DISCUSSION:** Attorney Eberly presented **1. Legal Docket CE-19-017 – Sun Re Corporation,** Milk dealer failed to account and make payment for milk delivered to it by a producer during October 2019, November 2019, and December 2019, in the amount of \$119,255.06. Defendant executed a consent order acknowledging the violation and consenting to the Board withdrawing \$119,255.06 from its security fund balance.

**MOTION by**: Member Van Blarcom

Moved to accept the consent order as presented. (1. Legal Docket CE-19-017 – Sun Re Corporation) Seconded by Consumer Member Hardbarger.

**DISCUSSION:** Chairman Barley inquired if they need to re-establish the funds in the security account before starting business.

Attorney Eberley commented that Mr. Zalman has been in contact with Sun Re Cheese informing them that they need a 75% bond posted, to start receiving milk again.

Attorney Beshore inquired that the law allows to have a bond instead of the security fund. Attorney Eberly stated that because their security fund was much higher than the bond calculations, they did not have a bond required. They no longer meet that qualification, nor other qualifications in the Security Act, the Board can increase the bond based on financial condition or change in milk purchases. Given that Sun Re Cheese has demonstrated non-payment, the staff would like to see more protection for the producers.
