3. PUBLIC INPUT (PERTAINING TO GENERAL ISSUES:

DISCUSSION: Chairman Barley stated the following about Dean Foods.

- Pennsylvania Bond claims are covered by the Milk Producers' Security Act. The Act requires that the Board hold a hearing to determine the amounts owed to producers. Staff must audit the seven Dean plants that we bond. If producers have not been paid when we finish the audits, we will hold the hearing.
- Hearing, order, etc, procedure
 - o Should be quick turnaround
 - Dean owes the money and acknowledges it owes the money

- o Board issues order telling surety companies to pay on the bonds
 - Surety companies send a check to the Board
 - Board deposits check in Treasury
 - Treasury pays producers
- The bond claim procedure takes time
- We spoke to Dean and its bankruptcy counsel Tuesday
- We think there is a possibility that independent producers will be paid by Dean before we can complete the entire bond claim procedure
- We will continue to monitor the producer payments as we complete the Dean audits

1. Petition from PAMD to consider adjusting over-price premium cross sections.

PRESENTED by: Chairman Barley

DISCUSSION: Chairman Barley stated that PA Milk Dealers are requesting a petition to consider adjusting the over-price premium for cross sections, using the calculations for the over-price premium according to the OGO A 9-25. Due to the changes in ownership in PA, they are now cooperative owned. They request that we expedite it and have it in July. This probably not be something we may be able to do in July with everything that is going on. We will need to figure things out.
